

# SOURCE OF ZINC, MANGANESE, COPPER, COBALT, IODINE AND CHROMIUM FOR USE IN ANIMAL FEED ONLY

This product is intended solely for the purpose of meeting the nutritional zinc, manganese, copper, cobalt, iodine, and chromium requirements of cattle.

## PHYSICAL DESCRIPTION

IntelliBond VITAL 5 Cr is a brown, granular powder that weighs approximately 68.6 lb/ft<sup>3</sup>.

#### **DIRECTIONS FOR USE**

For best results it is recommended that a nutrition professional be consulted to determine an optimized feeding level. **Feeding guidelines**:

- Feed at a rate of 4 6 grams/head/day for cattle consuming 20 25 kg of dry matter/day
- Feed at a rate of 3 4 grams/head/day for cattle consuming 10 20 kg of dry matter/day
- Feed at a rate of 1 3 grams/head/day for cattle consuming 5 10 kg of dry matter/day

#### **STORAGE**

Product should be stored in a clean, cool, and dry environment. It is advised that a system of "first in/first out" be followed to ensure optimized product quality.

#### **CAUTION**

As is the case with any trace mineral ingredient, excessive levels of zinc, manganese, copper, cobalt, iodine, and chromium can be toxic. Do not feed to sheep or related species.

Follow label directions. Chromium from all sources of supplemental chromium cannot exceed 0.2 part per million of the complete feed for broiler chickens and swine and 0.5 part per million of the complete feed for cattle.
